centre. Amy says her main influences are Jessie Jay and Pink and she is also a big fan of Tina Turner.


"I'm not really bothered about fame, I just want to sing and I am happy to do that in my local community," she added







New charity celebrates top award

A WARRINGTON based charity backed by Wolves rugby league star Lee Briers has been voted "Best new charity" of the year at a national awards ceremony in London.

Rett Syndrome Research Trust UK was presented with the Best New Charity Award at the Just Giving Awards 2012 at Shoreditch Town Hall, London.

Father of two Briers, aged 33, decided to back the new charity Rett Syndrome Research Trust UK, because of his longtime friendship with Andy Stevenson, fellow dad and father of daughter, Beth aged 12, who suffers from the condition, which is a devastating childhood neurological disorder for which there is no cure. Andy said: "We are naturally delighted to receive this award. Lee has

been a massive help in getting Rett Syndrome known in the wider community and a great support to me personally. Nothing has been to much trouble for him.

The condition first strikes previously healthy little girls between the ages of 6-36 months and robs them of their speech, normal movement and the ability to use their hands.

Then begins the long regression that may leave her in a wheelchair. Extreme anxiety, Parkinson-like tremours, seizures and orthopaedic problems are common. Álthough many girls live into adulthood, all are at increased risk of sudden unexplained death.

But researchers know that Rett Syndrome is caused by mutations in a gene called MECP2. This gene makes a protein which is required for proper maintenance of brain function. Recent research has demonstrated that if proper levels of the protein are restored, the symptoms of Rett Syndrome are reversed in laboratory models of even late-stage disease.



Other notable decisions in 2011 include the decision to establish a social




enterprise business in the form of the Resolution Training Co, which aims to generate income and to offer our expertise to the public and commercial sectors.

Ball during the IRA town centre bombing should never be forgotten.

He added: "The bombings had a profound impact upon the local community, and ripped two young children from their families and friends. The Foundation has become an important force not only in condemning terrorism but also in encouraging reconciliation and it continues to welcome visitors from across the world to its Warrington headquarters."

The Foundation's chief executive Clare White will visit the European Commission in Brussels this week to speak at a conference examining the role that victims can play in the fight against terrorism.

Welcome

Last year was another interesting year for the Foundation with new developments and progression on many fronts. We rebranded at the beginning of the year with a new logo and website and focussed on moving the organisation forward based on our vision of 'supporting others affected by conflict to build Peace'.

In April we launched our social enterprise, The Resolution Training Company, aimed at using the experience we have gained over the last decade to provide training to professionals, corporate bodies and Government agencies. To date we've trained people working in housing associations, the British Army, the Police and emergency responders.



Our links with academia continued and Foundation staff have given seminars and lectures at Universities both in the U.K and further afield. And we've hosted two conferences ourselves, which were attended by professionals and government officials both from the U.K and abroad.

We continue our work to support veterans and during the year have expanded our services to include working with the Army's Casualty Notifying Officers.

While the economic climate is still uncertain, the Foundation's quality of work is evident and we now need to raise our profile and ask communities to come on board to help us help others. To that end the Foundation will launch a community fundraising campaign this year and more on this can be found at www.foundation4peace.org.

Sharing Experiences residential



Back in October, the Foundation held a 'Sharing Experiences' residential. These residentials bring together people affected by conflict and terrorist incidents. Creating a safe and supportive environment, people are able to reflect on their experiences in relation to conflict by providing an opportunity to tell their story. Participants are able to identify with others with similar backgrounds to gain mutual support and growth.

Written by Jenny McMahon who participated in October's event:

The Peace Centre is a haven for peace and tranquility, a time for reflection and the opportunity to meet others and share experiences. It is also a place of fun and laughter, and making new friends. It is an ideal meeting place, a special place for all those affected by conflict and terrorism. It is unique in how it functions and the care and professional attitude to individual needs is paramount.

You can guarantee a very warm welcome, friendly atmosphere and kind hospitality.

You can guarantee a very warm welcome, friendly atmosphere and kind hospitality. You feel part of a family once you have attended this event, you are given the opportunity to tell your own personal story and listen to others, some very inspiring, others very tragic, but all with a common theme.

Everyone affected by terrorist activity or conflict either as a survivor, bereaved family member, loss of a colleague or friend, witness or a member of the emergency services, is encouraged to attend this event. The weekend is well structured into small groups, with the opportunity to participate in various sessions. All participants are encouraged to join in the activities and discussions, or just join in whatever they are comfortable with. Nothing is compulsory.

It is important to have your voice heard.

The professional staff are aware that telling your own story can sometimes open up old wounds as physical and mental scars can often be deep rooted. For many it can be difficult to discuss past events with family, friends or colleagues, or they don't want to listen or do not understand your feelings. It is important to have your voice heard and sharing your personal experience can help to release the burden you have carried for years or even decades.

This is an ideal opportunity not to be missed, with time to gather your thoughts, tell your own personal story in your own words in a safe friendly environment, without intimidation or criticism.

I thought I would be nervous talking to others but I felt confident in telling my story, it helps to talk about past events. Fears are dispelled. It is non-intimidating, non-invasive, non threatening. All members of the group are respected, confidentiality is maintained throughout and support amongst the group is overwhelming and encouraging. Hearing other people's stories from a different perspective is most inspiring. It helps to boost your own confidence. I can highly recommend attendance at the Sharing Experiences Residential.



The REACH Nonference

The 'Nonference' was the REACH participants' interpretation of what a conference should be; a gathering of individuals for fun, interactive and participative workshops. The event was a celebration and showcase of all the excellent work achieved throughout the two years of the REACH Project and was the final fanfare. Aimed primarily at professionals and those with an interest in working with young people - the event saw the sharing of experience and best practice. True to REACH and our approaches as a Foundation - the Nonference was designed and delivered by REACH participants, 19 young people playing a role on the day varying from presenting to delivering activities to the attendees.

The Nonference was kick started by REACH's Theatre production of 'Sticks and Stones,' a powerful and moving dance based performance told the tale of two teens, Chap and Stacey and the daily conflicts that they face. This allowed the audience to instantly start to identify with some of the challenges and issues facing young people and the struggle to deal with these.

Following on from the performance the 'Jeremy Vyle Show' took place. This was a participatory exploration of the conflicts affecting young people in the performance. 'Jeremy' interviewed Chap and his parents. This allowed attendees to interact and contribute their ideas as to what was underlying the conflict - as well as to offer ideas about how these two parties might be able to increase their understanding of one another and heal their fractured relationship. Whilst the 'show' had a very serious side to it - it was an entertaining and interactive opportunity for the audience to get involved with and explore the issues contained in the performance.

During the Nonference, attendees had the opportunity to experience some of the unique ways in which the Foundation worked on REACH; by taking part in one of the two workshops exploring conflict and leadership.

it was the young people themselves who led and delivered the two workshops to provide attendees with a flavour of what they had been doing on REACH!

Each Delegate got the choice to participate in one of the following workshops:

'Inspiring Leadership'

This workshop explored how leadership and teamwork was embedded into the REACH programme, through varied and innovative opportunities for young people. The workshop was interactive with activities allowing participants to experience some of the methodology used in the sessions.

'Doing Things Differently – working with conflict'

This workshop was an introduction to key topics relating to conflict and conflict resolution, through practical and engaging activities the young people delivered. The young people also shared their responses to conflict with the group and discussed how with training, they are better able to manage their own conflicts.

Walk Through Exhibition

The start of the REACH project was the beginning of a rich, creative, supportive, varied and nonstop journey that the young people were to embark on. They felt that this was an important aspect of their project and wanted attendees to gain greater insight and understanding about this.

There was a variety of creative stands, exhibitions and stalls, where attendees were able to experience the different topics as the young people delivered presentations, gave demonstrations, speeches and explanations about the displays of work. With a little help from members of the Fire Service and Professional Mentors, the stands provided a flavour of what the project was all about.

It was while living in New York, the cupcake capital of the world, and tasting the delights of cupcakes from such places as the Magnolia Bakery (of Sex and the City fame), that Carole developed her love for baking and cake decorating. From the first cake she 'created' for her son Charlie's 1st birthday in 1997, Carole realised she had a passion and a talent and soon established herself as the official baker for family and friends. On returning home to the UK in 2003 to have her daughter, Olivia, Carole's love of all things cakes continued and she spent her free time perfecting recipes and honing her modeling and sugar crafting skills. In July 2010, with the help of a very supportive husband and family, Carole finally realised the dream of turning her hobby into a business and opened Sweet Olivia.





Paul Hollywood's Gruyere Biscuits

Peace of Cake is about sharing great food with your friends, having fun and raising money for our vital work. You can bake anything you like - your Aunty Joan's favourite Apple Pie, your best brownies, scones, or even savoury biscuits. Paul Hollywood, judge on the BBC Great British Bake Off, has donated a fantastic recipe to inspire you!

Heat the oven to 200C and lightly butter two baking sheets or line with baking parchment.

Sift the flour and salt into a bowl or food processor. Add the butter and rub in lightly with your fingertips until the mix resembles breadcrumbs – or blitz in the food processor. Add the cheese, then bring the mixture together with your hands or process into a soft dough. Wrap in clingfilm and chill for 30 minutes.

Put the dough onto a lightly floured surface and roll it out to 5mm thick. Using a 5cm cookie cutter, cut out rounds and put them on the baking sheets, about 10 to a sheet, leaving plenty of room for spreading.

Bake the biscuits for 10 minutes or so, until spread out and browned lightly round (watch them because they colour very quickly). Slide them onto a rack to cool and then store them between layers of baking parchment in an airtight container.

Enjoy! These biscuits are gorgeous, but more importantly will help to raise vital funds for our work with veterans, victims of terrorism and young people.

Work starts on new IT suite

WORK has started on a new £35,000 extension to Warrington Disability Partnership's (WDP) popular Learning Centre.

The brand new IT suite which will a named in honour of former sability campaigner Marjorie be disability campaigner Marjorie Griffiths, the town's first ever free woman of the borough, will help cope with increased demand for disabled people to learn new skills at the Centre for Independent Living in The Centre for independent Living in Beaufort Street. Users enjoy a full range of IT courses ranging from Computers for the Terrified to Job Search Skills and accredited courses. Learning Centre Co-ordinator, Maria McPartland said: "Within the

first few months of opening the IT suite we realised that it wasn't big enough for the numbers of people wanting to use it. The latest extension will not only allow us to increase the number of people attending each IT class but it will provide space for us to further develop the range of courses we offer.

Once completed the existing IT Suite will be used as an additional classroom. Courses planned include confidence building, a camera club, one-to-one job search sessions, jewellery making and a range of other courses.

Funding for the project has seen contributions from a number of partners including The Griffiths Court Foundation, Warrington Borough Councils Public Service Agreement Fund and WDP's own fundraising efforts. Additional IT equipment has been supplied by Leonard Cheshire Disability and the National Institute for Adult Continuing Education (NIACE).

Main contractors Eyes Construction are carrying out the work at a vastly discounted price to help promoté community cohesion.







Housing improvements to be speeded-up

MAJOR improvements to thousands of homes in Warrington are to be

brought forward - in some cases by as much as two years. Golden Gates Housing Trust (GGHT) have announced plans to accelerate its multi-million £ investment programme for homes and neighbourhoods. The Trust, which celebrated its first anniversary at the end of last year,

says it will: * Complete the installation of all new double glazed windows, security

 Replace bathrooms where identified in three years rather than four, with an additional 1,402 tenants now added to the programme.
 Complete the installation of 1,980 new A rated central heating systems to properties in two years rather than four, with 753 systems replaced sooner than promised.
 Replace kitchens in 3,348 properties with an additional 855 homes dealt with sooner than promised.

The improvements mean the properties will be of a new, higher standard "The Warrington Standard"

GGHT's board of directors say they are committed to ensuring tenants. benefit from increased income that will be generated by this year's rent increases, along with efficiency savings made over the last 12 months. As a result, up to 30 new jobs will be created, along with 20 traineee

and apprenticeship positions. Tenants are also benefiting from savings on their energy bills as a result of a renewable energy project between GGHT and Warrington Borough Council. By the end of this month, more than 600 properties will have received solar panel installations, generating electricity from sunlight and giving customers a saving on their energy bills of between £70 and £120

GGHT chairman Roy Smith, said: "It is great news to be able to announce that we will be bringing forward these improvements for our tenants. We recognise that it is a difficult time for many people financially at present and we have targeted improvements that will help our customers to some means on their energy and water bills."

Avoiding errors and unnecessary tax charges

Understanding the relationship that a director/shareholder has with his/her company is critical if errors in operating the business, and unnecessary tax charges, are to be avoided. The main things to keep in mind are as follows.

The company's cash belongs to the , company.

Some people operating their business fail to understand that they must not spend company's cash on personal spend company's cash on personal items, and this is especially true if they are the only person involved. Unfortunately, to do so could amount to a loan from the company to the director. Not only is this illegal under the Companies Act but may also: • Amount to a distribution, resulting in a Corporation Tay, charge on the

- Corporation Tax charge on the
- overdrawn amount. Result in a Income Tax being payable on the benefit-in-kind unless interest is paid by the director
- Erode the protection of limited liability, resulting in the director incurring a personal liability for the company's debts

To avoid this, the company can pay

some mix of salary and dividend to the director/shareholder, although the company must always consider the legality of any dividend paid.

The company's assets belong to the company.

If the director/shareholder uses company's assets for their personal use then' they may incur an Income Tax charge on the resulting benefit-in-kind. The most common and expensive example of this is the provision of a company car and fuel. There are published rates which set the taxable penefit if a car and/or fuel is available for private use, and in most cases these are at a punitive level. Another example is the provision of a residence to the director/shareholder. However, personal use of any asset will, with minor exceptions, result in a benefit-in-kind.

The director's personal liabilities belong to the director.

If the company pays a bill which belongs legally to the director then this is not charged to Income Tax as a benefit. Instead, it is the company meeting a

"pecuniary liability" of the director. This is specifically subject to PAYE, and gives rise to a charge not only to Income Tax but also to National Insurance. The most common example of this happening is common example of this happening is the cost of telephones, especially if the company operates from the director's home. The contract is often between the telephone provider and the director. Even if the telephone is used for company business, however, this results
