



Our readers respond - Why bother with New Year's Resolutions - no one really keeps them anyway

Certainly this reader has an honest concern. It has been estimated that around 75% of people who make a New Year's resolution fail.

So why bother making a resolution if you almost 'know' you won't be keeping it? Perhaps these are goals such as weight loss, or to quit smoking, or procrastinating. There may be an element there of making the resolution as a result of obligation or guilt. The only way a resolution should be

made is for your own benefit. There is a pull between doing what we know we should be doing – or not doing – and just continuing in the path of least resistance because it is easier and

though unwanted, it is familiar. If you feel the same way as our reader, don't despair. Everyone who is honest with themselves can think of an area in their lives – or two or three that needs improvement. So instead of making a resolution which has connotations of failure, think of your goals in a different way. Don't label your goals as resolutions. For many, I believe that the connotation of 'broken New Your's resolutions' is bardwitted New Year's resolutions' is hard-wired

into our mind-sets.

Instead, look into an area of your life that you know you want to change. And you don't have to do this at the New Year – any time will do! In fact, give yourself some time to recover from the hectic holidays first!

If you have times when you slip, this It you have times when you slip, this doesn't mean you have to give up. It takes at least 21 days for new activities or thoughts to become a habit, and even 6 months for them to become second nature. If you know that going into it, you can be gentle with yourself. Don't get upset with yourself. Just as a young toddler learns to walk – falling down and picking themselves up again – you can too

themselves up again – you can too. Break your goal up into sections if you can, rather than looking at the you can, rather than looking at the whole goal. This works especially well for weight loss. Set a realistic goal of 5 pounds, and just repeat it until you are at your goal weight. This helps you to see progress more clearly than looking at the larger amount! But there are some other suggestions that may be beneficial for you to achieve your goal

WARRINGTON'S Golden Gates Housing Trust (GGHT) celebrated its first anniversary with a new service and a review of its successes.

Chief executive Peter Mercer launched the trust's new digital television and Smartphone site to kick start the day. He then visited a tenant who had a new bathroom installed as part of its capital investment Programme.

Ballot

GGHT launched last year following a successful ballot in which 91.9 per cent of tenants voted in favour of transfer from Warrington Borough Council. Since then the trust has started work

Since then the trust has started work on a massive investment programme and plans to spend £105 million over five years, improving homes and neighbourhoods to "the Warrington Standard".

Work in the first year includes fitting new energy efficient doors and windows to 1,420 properties, installing 223 new kitchens, 136 new bathrooms and completing fencing at 124 of their properties. New energy efficient boilers, cavity wall insulation, loft insulation and solar panels have also been installed. The trust has cleared its backlog of

The trust has cleared its backlog of Aids and Adaptations and has recruited two new handypersons to help improve homes. It has also worked to tackle anti-social behaviour. On transfer the trust made a commitment to support local

employment and in the first 12 months has filled 26 jobs with local people, including the recruitment of 10 apprentices to work in all areas of the business.

Mr Mercer said: "It is hard to believe that it is only 12 months since we launched as GGHT. We recognise that there is still plenty of work to be done as we aim to improve our neighbourhoods but I am extremely proud of what we have achieved in such a short period of time. I am looking forward to building on our successes and achievements over the next 12 months."



Charity celebrates 20 years on the buses

Distribution centres – a target for criminality

NOT too long again I was asked to NOT too long again I was asked to investigate a major burglary at an International Distribution Centre. My first port of call was the CCTV system that was in place in the Centre. However I was told by management that the CCTV system had been closed down on the night of the crime and there was no recording A little further of the crime and there was no recording. A little further investigation showed that the system in the guard house had been switched off and the thieves believed by doing this that the camera was not recording. Surprise Surprise, the CCTV cameras had been recording and guess what, the pictures clearly showed that the security guards on site had taken a part in the whole burglary ably assisted by outside offenders. This was a clear example of collusive theft and conspiracy.

example of collusive theft and conspiracy. The site security officers thought that they had control of the CCTV system and they knew exactly when the theft could take place and how easy it was to do it. Luckily they where caught on that occasion because a little forethought and planning ensured they did not know all the risks that they where taking. When we are considering the

When we are considering the security risk related to Distribution Centres we have to consider the main overall control of shrinkage due to internal as well as external criminal activity. This is not to discount in any way shrinkage due to accidental or malicious damage

or account fing error. Through specialising in the security of Distribution Centres, Uniqwin have been proactive in developing planned systems and procedures that can be adapted quickly to deal with all the security risks of Distribution Centres.

smokescreen to camouflage criminal acts. Collusion can take place by linking internal theft with a goods driver, admin/accuracy errors can be leading sources of shrinkage. Managers and company bosses never imagine that they could lose so much in quantity or value from under their noses and that trusted long term employees could be involved. However developing companies have taken on quite sophisticated systems to identify any loss as it occurs. Intelligence awareness and prevention can impact on these losses. Simply enacting proper checks and balances from checks and balances from beginning to end will go a long way to keeping shrinkage to an allocating a lot of money but simply how effectively and strategically you spend it.

Here are some tips on reducing the risks:

the risks: 1) Accurately assess the risk. Where is the centre located? Do the goods have a high street value, what processes, policies and technologies and guarding is in place and, are they all working? How long is it since the last security audit was carried out audit was carried out (recommended every three years) 2.) Start your loss prevention

4) Control access to the centre restricting it to people who need to be there. Vehicle drivers should not be intere. Venicle arivers should not be allowed into the centre and should have a separate waiting area. Visitors should be badged /verified with a picture ID and escorted at all times. Access controls should limit employee movements to designated areas.

5) Identify systematic problems and unusual activities to see if there are patterns of loss. Have regular checks carried out on waste bins.

6) Consider undercover investigators where loss problems occur and provide whistle blowing facilities.

7) Provide technology solutions where you can and ensure that access to controls particularly historical evidence is limited.
8) Use a layered comprehensive approach to your security ensuring that it does not impede production but is effective.

Integrating your security systems can prove most effective but they do need proper coordination to ensure they are not in conflict or that you are duplicating unnecessarily.


designed a Patchwork Cape, modeled barefoot on the night, explaining "My inspiration was the the music of the 1970s and the hippy movement.





Warrington Disability Partnership (WDP)

WDP is a user led voluntary organisation which actively promotes independent living throughout life and work. Based in Warrington; our team consists of 12 trustees / directors, 220 volunteers and just under 50 paid staff who together deliver a range of services directly or in partnership with health and social care providers, education/employment services and a wide range of local support groups and services.

Chair of Trustees & Chief Officer Report Dave Thompson MBE DL (Chair) & Jayne Horton (Chief Officer)

On behalf of 'Team WDP' we are delighted to welcome you to our 2011 Annual Report.

We thought that 2010 was a great year for WDP but the past twelve months have been even better. However, it didn't start off that way! Last December, whilst the team was working hard to deliver a huge programme of Christmas fundraising activities, work was going on behind the scenes to assess if we could afford to run the 20th Anniversary 'Disability Awareness Day'. In early January we tabled a proposal to the Trustees that included a 20% reduction in the budget and a shortfall of £25,000, an ambitious plan. We are pleased to say that the Trustees voted unanimously to back our proposal to spend the next six months raising the money.

In February we launched the first 'Going the Extra Mile' event titled 'the Scuba Challenge'. Sixty four lengths of Fordton Leisure Centres swimming pool certainly captured everyone's imagination! Over twenty scuba divers and swimmers completed the challenge raising over £18,000. More importantly it raised awareness of our campaign, attracting several individual donors and three new sponsors. Taking the total raised to over £30,000. This proved vital when, in June, two more sponsors pulled out. We would like to thank Terry Woods and his team from Cybaqua for their support.



Also in February Fiona Philips visited the Centre to film a Panorama Special on unemployment, which featured our employment team. Several more TV production teams have expressed interest in our sex and disability project.


News wasn't as good for three local charities, as they announced closure during the year, the Griffiths Court Foundation, Warrington Community Law Centre and the Council for Voluntary Services.

In March we launched the Disability Trading Company (DTC), the trading arm of WDP. This uses a social enterprise model with profits transferred to WDP to help maintain current services and to enable us to develop new services. DTC has already been recognised by the Department of Health and has received interest from other voluntary organisations, local authorities and Primary Care Trusts.

Throughout April fundraising was high on the agenda, with our usual Easter activities, Manchester 10k Run, and events held by other organisations including Warrington Swimming Club. Our annual team 'Away Day' attracted over 100 Team Members including Trustees, staff and volunteers. As well as sharing our plans, the event also provides an opportunity to share ideas and any concerns. During the day we worked towards developing a set of organisational values, setting out our collective vision on how we should conduct ourselves.

May started off with the 'Kayak Challenge' that was developed under the banner of 'Going the Extra Mile'. It brought together new supporters and added an extra buzz. WDP's learners celebrated success at the Adult Learners Awards, David Carey received the 'John Tickle' Disabled Learners Award and WDP received the overall 'Group' award. During May we launched our 'Young Persons Forum' which has continued to grow throughout the year.







In June we signed off 3 years work on the £1.3million refurbishment project of the Centre for Independent Living. The Lord Lieutenant of Cheshire David Briggs MBE, led the official opening ceremony in front of sixty invited guests. It was a very special day for 'Team WDP' and our partners Warrington Borough Council. Together we would like to thank the Big Lottery for the main grant of over £923,000, and our other supporters including WREN, St Georges Healthcare Group, Bond Hotel and Fairview Windows, plus the hundreds of people who supported our massive fundraising efforts.

The 10th July marked the 20th Anniversary of Disability Awareness Day, capping a fantastic week that met with a royal seal of approval from Her Royal Highness the Countess of Wessex. Her presence attracted massive media interest including a team from Granada Reports who returned for Sundays main event, both resulted in reports on ITV's regional news. Our VIP guests included eight government officials from Thailand and a World War Two Dakota fly past. The day was made even more memorable with news that the Message Institute based in India had run a successful Disability Awareness Day on the 10th July, making DAD 2011a truly international event. Later in the month, the Minister for Civil Society Nick Hurd MP visited the Centre.

In September 'Team WDP' held our 20th Anniversary celebrations at the Town Hall. We were honoured to be joined by fellow founder members Eric James and Alan Shaw; this was the first time that we had been together for nearly 16 years. During the event we also announced our new Community Patrons, Professor Steven Broomhead, John Gartside OBE, Lord Doug Hoyle, Pete Pinnington, Peter Ives, Liz Smith and Dr Sarah Baker.

October saw the opening of our new Mobility and Independent Living Store that we have developed in partnership with the Golden Square Management Team. In mid-October we ran our 8th annual North West Positive Action Awards where 14 awards were presented to individuals, small and large employers, service providers and voluntary organisations. We would like to thank NHS North West, Arena Housing and Sellafield Limited for their support.

Looking back, 2011 has been a year packed with milestones. Looking ahead there will be many challenges in maintaining the funds required to deliver our current services. Our Disability Trading Company and new retail store are two initiatives aimed at raising new funds. During the year ahead we will continue to review our current services, and we will look for new opportunities.

On behalf of 'Team WDP' we would like to thank all of our partners for their continuing support, our fellow Trustees/Directors, staff, volunteers, the people who use our services and everyone who has supported us during the past year.

We look forward to working with you all next year.



Access and Training Self financed through income generation

Throughout the year our teams have continued to provide advice and support to 46 local businesses, developers, architects, voluntary groups and individuals. This advice ranges from general telephone enquiries to site visits and audit reports. Our staff have delivered disability awareness training to 718 people.

Accessible Caravans

Self financed from income generation and donations

Our two holiday homes in North Wales provide disabled people, their families or carers the opportunity to take an accessible and affordable holiday. Both of our caravan holiday homes have been designed to provide inclusive access for disabled people.

'Grenadier', based on the Harts site in Pensarn took 15 bookings during 2011. 'Guillemot' based on the Lyons Robin Hood site in Rhyl took 18 bookings.

Making A Difference

Benefits Advice

This service is un-funded

Our benefits advice service is run predominantly by volunteers meeting clients who require support to complete benefit application forms. During the past year we have secured over £615,000 in benefits for 322 local people. These include Disability Living Allowance, Attendance Allowance, Carers Allowance, Employment Support Allowance, Income Support and Pension Credits. General advice was given to a further 558 people.

Centre for Independent Living

Equipment Showroom – Funded by NHS Warrington & supported by Warrington Borough Council Wheelchair Loan and Equipment Hire Service -Self financed through donations



Our Equipment Showroom has a range of independent living equipment on display including bathing, toileting, mobility, stair lifts, recliner chairs, and adjustable beds. Following the launch of our Disability Trading Company in February 2011, the range of products now available to purchase from the Showroom has been expanded to include larger items (scooters, recliner chairs, etc). Our staff and volunteers also offer information and advice on a wide range of other topics including sensory impairments; accessible holidays, days out and work closely with local Housing and Care Call services.

During the year, 15,105 people have visited the Centre and we received 3,834 telephone enquiries to the showroom. We also loaned out 732 wheelchairs, and 76 pieces of equipment to local people. Our team of 12 volunteers dedicated 2,567 volunteer hours.

Making a difference

"I visited the CIL with my family in need of some help and advice on equipment, was in the process of waiting to see a doctor and still unaware what my illness or disability was. The staff spent time with us explaining what was available and discussed how to get my own permanent wheelchair. We loaned a wheelchair whilst waiting to be assessed and also purchased a few small daily living aids to help me around the home. A few weeks later I came back with my family to give an update on my prognosis and took information away on Shopmobility, Direct Payments and WDP's Learning Centre activities." Thank You



Community Cafe (The Galleries)

Self financed from income generation Furniture funded by a West Area Neighbourhood Board Grant and Conservatory Supported by Fairview Windows

Our Galleries Community Cafe is a pleasant place to stop for a rest and a bite to eat. You can have a tea, coffee, soft drinks, snacks or a meal after you have explored the wide range of equipment available in our showrooms.

We also provide a catering service which is available for outside catering or for use if you have booked one of our meeting rooms. We have served 2,734 lunches and buffet lunches for 432 people during the last year.

This year's 20th anniversary event attracted 240 exhibitors and 28,000 visitors. Our team dedicated 2,640 volunteer hours. A huge fundraising effort contributed over £30,000 to this year's event.

During DAD Week 2011, the team were honoured to receive a royal visit from HRH Sophie Countess of Wessex to the 'Inspire Your Life' event, organised by 5 Boroughs Partnership NHS Foundation Trust. This, as well as a fly-past from an RAF Dakota, visitors from the Thai government, DAD India and media coverage including two news reports on Granada TV made the 20th Anniversary event, one to remember.

Disability Information Point – Warrington Retail Market Staffing is self funded, the stall space is supported by Warrington Borough Council's Retail Market

Our team provide information and advice on a wide range of disability related support. We also operate a satellite Shopmobility service, which offers scooters, electric and manual wheelchairs. Our team actively support our Fundraising and Events programme.

Throughout the year 18 volunteers have helped to answer 4,939 enquiries and co-ordinate 1,024 loans of our scooters and wheelchairs.

Engagement & Partnerships

WDP are represented at over 120 meetings locally, regionally and nationally to ensure that disability matters are on the meeting Agenda. Meetings range from local Support Groups to Warrington's Local Strategic Partnership and the national Sexual Health & Disability Alliance. This ensures that we are promoting social inclusion and breaking down barriers.

Warrington Disability Partnership Annual General Report 2011

Employment Team

Funded through Skills for Jobs 'Routeways' programme by Warrington Borough Council plus Work Programme sub-contract from Avanta and funded through Department for Work and Pensions and European Social Fund plus sub-contract from Greater Merseyside Connexions funded through Skills Funding Agency plus other funding support via Lancashire Colleges Consortium.

The team provides a user led accredited Information, Advice and Guidance service and supports volunteering, work placements, supported employment, work trials, and routes towards part and full time employment. We deliver the mainstream 'next step' service, (166 advice sessions delivered this year), and the recently launched government 'Work Programme'.

The Lavender Hill project, for people aged 50 and over, provides skills, financial and health checks to improve training and work opportunities. A scoping project in partnership with WBC's Supported Employment Team provides learning and work opportunities for people with learning difficulties/disabilities.

Work Clubs and Can-Do clubs are at 10 venues supporting local engagement and the Health and Wellbeing of residents. Employers are supported to sign up for the 'Two Ticks' disability symbol and to promote best practice in recruitment and retention alongside mental health and wellbeing in the workplace. The team also advises on 'Access to Work' and administers the 'Towards Work Support Fund', from which 44 local people have benefitted.

The team now supports a total of 965 clients, of which, (281 new clients for 2011). Throughout the year 3,887 phone enquiries have been received and 58 clients have successfully gained employment.

Finance & Payroll

Self financed through income generation

Our team offer a payroll service for Direct Payment users and small businesses. This includes registration of all employers/businesses with the Inland Revenue, processing payroll from time-sheets, producing payslips and ensuring all Tax and National Insurance are paid to the Inland Revenue by due dates. We also support our Treasurer and Chief Officer in producing Management Account Reports for the Board of Trustees and Project Management Reports for Team Leaders to submit to funders.

The Payroll team currently support 299 employers, with 504 employees. Throughout the year, the team have received 2267 phone enquiries.

Fundraising, Promotions & Community Engagement

Community Engagement financed through LSPA funding. All other areas self-financed through donations and fundraising

Fundraising plays a vital role in supporting many of the self financing or un-funded services offered by WDP.

Our calendar over the last twelve months has been busier than ever with over 80 events attended. These included community events, carnivals and information days. alongside our own Easter & Christmas tombolas, raffles, "Santa's Grotto", Going the Extra Mile Events, the Bupa 10K and Disability Awareness Day. Around 32,000 were engaged with at these events, which have all helped to raise awareness of disability and the services offered by WDP. In addition, our Community Engagement officer liaises with local community groups.

Earlier this year, we were proud to have been appointed 'Charity of the Year' for Sainsbury's Warrington and thank the team for their continued support.

Independent Living Team

Funded by Warrington Borough Council Direct Payments Service Level Agreement.

The Independent Living Team supports clients throughout the whole process of setting up and running their 'Direct Payment' and 'Personal Budgets'. This supports them with their independence, whether it may be using an agency or employing their own Personal Assistant (PA).

The support includes recruiting, advertising, interviewing, contracts of employment, Employer Liability Insurance and Criminal Records Bureau checks, along with any day to day problems they may have with the running of the Direct Payment. We also work closely with our Payroll Service to process wages, holidays, tax calculations and pay slips. The Independent Living Team have also been involved in a 'Support Brokerage' pilot project, ran by Warrington Borough Council, for clients receiving Personal Budgets.

The Independent Living Team currently supports 482 clients. 137 referrals have been received during the past 12 months.

Learning Centre & Meeting Rooms

Funded by Warrington Borough Council's Life Long Learning and supported by Leonard Cheshire, UK online, Warrington Collegiate and WREN.

Our Learning Centre has received 3,618 visitors, including visitors to our Discover IT Suite, Meeting Rooms and participants in a wide range of classes.

Our Discover IT Suite runs a variety of classes for disabled people, their families, their carers and members of the local community. Specialist software, along with adapted keyboards, mice, fully height adjustable desks aims to make this facility accessible to everyone.

During the past 12 months we have had 851 meeting room bookings, 1,935 IT sessions and over 720 hours in the Discover IT Suite. These include: 'Computers for the Terrified', 'Basic IT for Learning Disabilities', 'Office Skills IT' and 'OCR Functional Skills' from Entry Level to Level 2.

We also offer a Camera Club, and members are involved with photo taking at WDP events, and other classes such as, "Confidence" and 'Arts & Crafts', which we are able to run in liaison with Warrington Collegiate.

Making A Difference

Leisure, Recreation and Sport

Funded by Warrington Borough Council and Cheshire & Warrington Sports Partnership Working in partnership with ASET, Aiming High for Disabled Children, Warrington Youth Club, NSPCC, Warrington Wolves Foundation and Warrington Swimming Club.

The team has been involved in a number of community based projects:

- Planet Blue Youth Club for 11 to 25 years olds with an average of 43 participants per week and over 100 members.
- Disability Inclusive Sports Club (DISC) for 11 19 year olds, attracts around 15 young people per week.
- Mini Disability Inclusive Sports Club (Mini DISC) for 5 11 year olds with an average of 23 attendees per week.
- One Wednesday Can't Hurt (OWCH) Pain Management Support Group with around 12 attendees per week. Children's Inclusive Swimming Club for 5 18 year olds, with 7 swimmers per session. Wheelchair Sports Club for anyone 11+ plus with an average of 6 people per session.
- Sports Unlimited (5 Hour Offer) developing an 8 to 10 weeks initiative highlighting inclusive activities for young disabled people with an average of 38 people per session. This project finished in March.
- Leisure, Recreation & Sports Forum meets quarterly at WDP with an average of 10 people attending per meeting. The forum looks at ongoing provision in the area. It discusses key developments and success in the area to avoid duplication of services. This is a chance to share guidance and support of both local authority and voluntary sector organisations.
- Inclusive Disco monthly Discos are held at Chicago Rock for Young Adults aged 18+, with an average 20 people attending per week.

Mobility & Independent Living Store Developed in partnership with the Golden Square Management Team (Lend Lease). Staffing is self-funded.

Our new Mobility & Independent Living Store opened its doors in October. The central location of the shop in the Golden Square shopping mall brings greater accessibility for tens of thousands of disabled people and their families to this and other services from WDP.

The Store offers an extensive range of high quality independent living products at affordable prices backed up by a wide range of support services including our Mobility Workshop and Service Centre.

We have followed national recommendations to develop this new service and we are already receiving interest from councils, primary care trusts and other user led organisations with a view to them developing similar services.

The wide range of information provided in our 'Relationships & Sex Matters' packs are used by professionals or individuals to offer support and advice on the issues concerning sex and disability.

WDP is a member of the Sexual Health and Disability Alliance (SHADA) Group and this project has close links with Leonard Cheshire Disability. We attend regular 'Local Implementation Group' (LIG) meetings to ensure that disabled people are given the correct support from local NHS groups and Sexual Health services.

Shopmobility Warrington

Funded by Warrington Borough Council and supported by Golden Square Management, Lend Lease and Warrington Bus Interchange

Our Shopmobility service provides a vital life line for its 583 registered members who require mobility support to shop in the Warrington Town Centre and Golden Square. 390 day visitors have also used this service during the past 12 months.

Satellite services are available at Warrington Bus Interchange and the Disability Information Point in Warrington Retail Market.

During the past 12 months, our team of volunteers have given 3,470 hours, assisting in the loan of 6,053 scooters for 17.833 hours.

Many areas self financed from donations

We currently have a team of 220 volunteers, consisting of 140 regular volunteers across our services and another 80 volunteers who support DAD and ad hoc Fundraising events. In the last year, volunteers gave 30,605 hours to ensure we continue to provide the effective service our customers have come to expect.

Volunteers are spread over 17 departments with a number of Support Workers to ensure that all volunteers have regular support and the opportunity to develop their skills. 2 volunteers have achieved their NVQ level 2 in Customer Services and Business Administration through train to gain.

Our main switchboard is staffed by volunteers with years of experience and the Main Office dealt with 54,708 incoming and 30,008 outgoing calls during the past year

The outstanding contribution by WDP volunteers can be seen by looking at the number of hours completed and the financial cost. Should they be paid by the National Minimum Wage this would cost the organisation £188,078.40.

Warrington Disability Forum (WDF)

The Warrington Disability Forum provides monthly meetings for consultation and information exchange with guest speakers ranging from the Warrington Borough Council's Deaf Services Consultation, Better Health services for people with Learning Disabilities (WBC & NHS Warrington) and Disability Hate Crime.

The Forum has a lively Agenda for discussion with on average an attendance of 17 members per meeting. In total there are 87 active members which include individuals and organisations with an interet in disability matters.

Wizard Narrow Boat

Self funded from income generation and donations; supported by Thorn Marine and the Barn Owl, Lymm

The Wizard is a unique wheelchair accessible 40 foot narrow boat that offers low cost day trips to the disabled people, their families, carers and support groups within the local community along the scenic Bridgewater Canal. During 2011, our team of volunteers have completed 3,069 volunteer hours to assist with 100 trips.

Friends and family who drive too fast

JUST over half of drivers believe they have a family member who drives too fast – while 56 per cent say they have a family member frightened to drive on motorways.

This is revealed in an AA survey which also finds that 35 per cent of motorists have a family member who drives while using a mobile phone, eating, shaving or putting on makeυp

Young drivers (18-to-24) are more critical of their friends' driving than any other age group. Almost three quarters of 18-24 year-olds believe they have a friend who drives too fast; 70 per cent say they have a friend who "tailgates" and 79 per cent have a friend who drives while using a mobile, shaving, eating or

using a mobile, shaving, eating or doing their make-up. Drivers aged 65 or older are less likely to have a friend they think drives too fast (43 per cent), tailgates (48 per cent) or drives while using a mobile, shaving, eating or doing their make-up (50%).

AA president Edmund King said: "A worrying number of us think our friends, tamilies and colleagues have illegal and dangerous driving habits. "Young people are particularly likely to have noticed dangerous driving habits amongst their friends.

"There is no way someone would pass their driving test if they displayed these types of behaviour, so there is no place for it on our roads.

However, , when questioned about their own driving skills, most motorists were confident of their abilities. More were contract of their abilities. More than 70 per cent said they were "quite" or "very" good at sticking to speed limits. Nearly 90 per cent denied tailgating and said they were "quite" or "very" good at keeping a safe distance from a car in front of them

Crossover SUV with breakthrough technology



The Mazda CX-5

MAZDA have chosen its CX-5 compact crossover SUV to introduce its breakthrough Skyactiv technology to the UK.

Weizer never chosen its CX-3 compact crossover SUV to introduce its breakthrough Skyactiv technology to the UK. The car arrives in showrooms in April and Mazda claim the Skyactiv technology helps make the CX-5 the lightest and most fuel efficient car in its class. The entry level 148bhp diesel will take the car from 0-62mph in 9.2 seconds but also return 62.8mpg, with an ultra-low 119g/km CO2 figure that means road tax is free for the first year. Mazda offers a choice of 148bhp and 172bhp diesels alongside a 163bhp petrol engine. The latter two can be specified with four-wheel drive, but the lower powered diesel is only available as a front-wheel-drive model. In Japan, the Skyactiv technology is already making waves. Mazda have won the Japan Automobile Hall of Fame "car technology of the year" award with a revamped Demio - known over here as the Mazda2 - equipped with then ew technology. Critics are already praising the diesel engines which they say feels more like a petrol engine than any other four-cylinder diesel on the market. The CX-5 is also an extremely practical crossover, with a 503-litre boot and rear seats which fold flat into the floor at the touch of a button to provide a 1,603-litre load area. During the coming year, Skyactiv technology will be introduced in a whole new generation of Mazda cars.

Campaigners win 20-year battle for station bridge

CAMPAIGNERS have won a 20-year battle to get a new bridge, with access for the disabled at Birchwood railway station.

The Department for Transport has announced it is making a £1 million "Access for All" grant towards the cost of a new footbridge, with two lifts for the disabled, linking the two platforms at Birchwood station.

plattorms at Birchwood station. A partnership made up of the borough council, Warrington Disability Partnership, Birchwood Forum, Stronger Together, Cheshire and Warrington LEP, Birchwood Town Council and others backed the bid.

Total cost the project, expected to

be completed in two years' time, is £1.4 million. Match funding of £390,000 has already been made available through the borough council.

Dave Thompson, chairman of Warrington Disability Partnership, said: "This is fantastic news for the whole community, not just for disabled people, also parents with pushchairs and prams, children, frail elderly, and those who have temporary impairments."

Ex-library reopens - with books galore!

Visitors can also enjoy a free tea or coffee while they relax in a lounge area with armchairs and settees. The hall can be booked by members of the community for a small fee - and is already proving a popular venue.



It is never too soon to plan for the current tax year

Like all firms of accountants we are Like all firms of accountants we are currently deeply involved in ensuring that client's tax returns for 2011 are submitted by the due date of 31st January 2012. However, it is never too soon to plan for the current tax year which ends on 5th April 2012. There are sovice approximations are some tax saving opportunities available which must be used before the end of the tax year or be lost.

One clear example is an investment into an Individual Savings Plan (ISA). During the current tax year, any individual can invest up to $\pounds10,680$ into an ISA. Of this, a maximum of £5,340 can be put into a cash ISA, ie into a cash-free bank deposit account. Any balance of the annual limit can be invested into a stocks and shares ISA, ie if no cash is invested into an ISA then the full allowance can be invested in stocks or shares.

You should remember that the limit of $\pounds10,680$ is for each individual. This means that a married couple can invest up to £21,360 during the current year.

However, also remember that an ISA will only save tax if you are a taxpayer.

They do not have any advantage for nontaxpayers, and these should ensure that they do not incur any additional charges. This leads to a simpler form of tax planning for couples. That is to ensure that, when a non-taxpayer, all investments are in the name of the non-taxpaying spouse. It is also important to consider pension

planning. There are limits to the amount that can be invested into pensions each year and obtain tax relief. Firstly, you can only contribute an amount up to your total earned income in the tax year. Secondly, there is an annual limit above which you there is an annual limit above which you will not receive any tax relief, and for the current year that limit is £50,000. Again, this is per individual so married couples, both of whom are working, can contribute up to £100,000. This could lead to some interesting tax planning for "one-man" limited companies. All payments to spouses must be commercially justified, but assuming this to be the case then a spouse can be paid up

be the case then a spouse can be paid up to the personal allowance, currently £7,475 subject to income limits. For
