COVID-19 test site opens as Cineworld closes

A "WALK through" COVID-19 test facility has opened in Warrington following the significant increase in cases in the town. The new pilot site opened at the Academy Way car park at the rear of the

Cineworld multi-screen complex. It compliments regional drive throughs but still has to be booked in

advance via the government portal. Meanwhile almost a year to the day after announcing 70 new jobs in Warrington at its new 13 screen cinema, Cineworld has become another victim of the COVID-19 pandemic temporarily closing its UK cinemas.

It is hoped that the Cineworld cinemas will be able to reopen next year, with staff being asked to accept redundancy in the hope of rejoining the company when theatres open again.



Warrington's history preserved with new digital archive

REGISTRATION documents dating back to the 19th century have been preserved in a digital archive for tuture Warrington generations, thanks to the completion of a council project.

thanks to the completion of a council project. Around 2,500 books containing the original birth, death and marriage certificates for Warrington residents, going back to 1837, have been digitised. The new electronic archive will be new resurce the irreplaceable books.

The new electronic archive will help ensure the irreplaceable books are protected against damage or loss, with registrars able to carry out historical searches for specific certificates or registrations electronically, without having to physically handle the binders, many of which are in a fragile state. It was decided that the time was

It was decided that the time was right to digitise the archives to preserve the records ahead of the relocation of the books, which were previously stored in the Register Office on Museum Street, to their new home – a high quality, secure strong room in the new council offices at Time Square.

The digitisation of so many registers is a painstaking process that involves individually imaging and scanning the registers and the entries within them into an electronic format. It requires specialist work, to minimise the risk of damage to the documents. The council commissioned Wakefield-based company, Microform Imaging – who have expertise in handling historical documents – to deliver the project.

The company has produced a high-resolution image of each individual register page/entry, which can be accessed for future certificate re-production. Registrar staff will now be able to easily access the electronic repository, in order to query and produce copy certificates, using secure, encrypted software which ensures the certificates cannot be accessed inappropriately.

inappropriately. Microform Imaging has also produced the scanned certificates in microfilm format, providing an additional failsafe backup for the Registers.

Registers. Warrington residents and other customers regularly request copies of historic registration certificates. Previously, only certificates from 1991 onwards were held electronically.

This meant that when a certificate from earlier than 1991 was requested, the registrars would have to search the binders, before producing a hand-written copy of the requested certificate.

Typically, the re-production of a historic certificate – many of which are ornate and decorated with stylistic calligraphy – would take the registrar 25 minutes, in addition to the time taken to search through the binders for the required certificate.





Death of business community stalwart **Colin Daniels**

BUSINESS community stalwart Colin Daniels, long-standing Chief Executive of Warrington & Vale Royal Chamber of Commerce has

Royal Chamber of Commerce has sadly died after a short illness. As well as the Chamber of Commerce, he was leader of the Conservative Group on Warrington Borough Council in the early 1980s and a long-standing Chair of Governors at Warrington & Vale Royal College. In 2016 he was honoured with the degree of Doctor of Business Administration, honoris causa by the University of Chester. He was Chairman of the

He was Chairman of the Corporation of the college since 1989, where he took a very proactive and strategic role, including the complete re-building of the college.

He played a significant role in the successful transfer of the College's


successful transfer of the College's Higher Education provision to the University of Chester in 2002. Mr Daniels served continuously on the board of the Colleges National Association and was chairman of the National Employment Committee and the National Joint Forum for Further Education until 2002. He was one of the joint

He was one of the joint architects of the introduction of the flexible employment contract for the Further Education Sector. He was a former member of both the Further Education Governors National Council and the National Self-Regulation Group for Further Education.

Education. He was also a Senior Council Member of the University of Chester and a former member of the Court of the University of Salford. From 1978 until 2012 he was chairman of Governors of his Thelwall Primary School. He also served on Cheshire County Council's education committee from 1994 to 1999. A past President and Treasurer

A past President and Treasurer A past President and Treasurer of the Warrington and District Association of the National Builders Federation, and a former member of the North West Regional Council of the National Federation of Building Trade Employers, he was a Life Member of the National Building Trade Employers, he was a Life Member o Builders Federation

He was also a former chairman



of Warrington 2000+ Ltd, which

of Warrington 2000+ Ltd, which owns and operates two office developments. He was also deputy chairman of Warrington & Co Ltd, which actively promotes the economic expansion and inward investment of Warrington. Mr Daniels was also chairman of Cheshire Chambers Enterprise Ltd, which serves the sub-region of Cheshire and Warrington. A former director of Chambers of Commerce North West Ltd, he coordinated the work of the 16 Chambers of Commerce in the North West Region. He was also very involved in the establishment of the Cheshire and Warrington Local Enterprise Council. Council.

Council. Mr Daniels was both a borough councillor and parish councillor from 1977 to 1986, leader of the Conservative Group and chairman of the parish council. In 1992 he was a Parliamentary Candidate at the General Election and, for five years, chairman of the Warrington South Conservative Association

Association. He served with the Royal Artillery in BAOR (British Army of the Rhine). His charitable work included Cancer Macmillan Nurses, Rytields Detected Village and as a trustee Retirement Village and as a trustee of the Warrington Charities Trust.

Darren's "virtual" marathon raises £1,500

SCHOOL attendance officer Darren Willcock raised more than £1,500 running in the "virtual" London Marathon.

He was one of some 45,000 people who ran the marathon in various parts of the world and he ran the last seven miles on the playing fields of his school – Warrington's Sir Thomas Boteler CE High School.

Sixty students and a number of other members of staff joined him for the final part of the run – spaced out in their "bubbles".

Mr Willcock, who had been training for six months for the run told the other runners: "I could not have done that without all of you as well. We never do things by halves do we? Every one of you on this field now: we've done this together."



School graphic designer and publicity manager Alice Roberts said: "Our school's team spirit soared high today. Darren's sheer determination, coupled with his unwavering care for the people around him is inspirational. We are incredibly lucky to know and work with him."

Mr Willcock was running in a charity place for the National Autistic Society, and has raised over £1,500 for them.

Headteacher Mrs Beverley Scott-Herron commented: "Events like this are the true epitome of everything we stand for as a school. Hope, compassion and endurance are our values, and this is what has been shown today. To watch a member of the Boteler team achieve a lifetime goal is so emotional and heartwarming. It gives me inspiration."

emotional and heartwarming. It gives me inspiration." Mr Willcock said: "At the begining, I couldn't even run a mile. And then I built up to 19 miles. And I never passed that until today. It just shows what you can do when you put your mind to it. Anything's achievable. I'm proud that I've finished, but I'm even more proud of all the students that took part. I couldn't have done it without their support. The staff and students were absolutely amazing. I've not done it – we've done it. And that's what we do best at Boteler. We do things together."

Harries very well and my addiction wasn't a laughing matter." Lisa, who appeared on the Jeremy Kyle show alongside Harries, said that was her biggest regret and was a huge career low for her. "I wasn't in the best head space, and if I'm honest I didn't even know her," Lisa concluded. "When she said I'd lied on the show to make it better. I was flabbergasted. 



MUM says housing association helped save her family's life

A WARRINGTON mum says a local housing association helped save the lives of her and her family after living through the trauma of childhood abuse, foster care and bereavement, abusive marriage, and the spectre of homelessness.



In fact, the former teacher would go as far as to say, being able to access affordable social housing when she needed it most "saved her life".

her lite". Margaret ended her abusive marriage after becoming afraid for her small children's safety. Her husband left the family, sold the

husband left the family, sold the house from under them, and went back to live with his parents. With no family of her own to turn to, Margaret said: "We were left without a home. I had nothing of my own; no money, but we could not stay in that situation. I needed to protect my wildrom with to protect my children, with my very life if necessary. That is when I was put in touch with Warrington

Margaret, then in her thirties, was determined not to let history

repeat itself. She said: "I only had a small teacher's pension and social security but WHA was so kind and, I would say, saved my life. If it had not been for their support, my little brood may not have survived without being put into care. I was determined not to let that happen as it had to me.

"They provided me and my three small children a lovely home that I still live in now. I and my three toddlers began a new life in this lovely house."

That "decent, safe and genuinely affordable home" gave the family the safety and springboard they needed to thrive.

Margaret added: "I'm so proud of my three children. My son is now an architect. My middle daughter is a staff nurse at Warrington General Hospital and my oldest daughter is a very experienced care worker for the disabled."

"I am so grateful for all the help and support I have received from Warrington Housing Association for saving my life and that of my

children, who are now serving the community as their life's work." Margaret, now 70, still enjoys the support of Warrington Housing Association as she plays an active role at WHA's over-50s centre LifeTime. She spent the lockdown taking part in quizzes and exercise classes over Zoom and Facebook art tutorials, in between helping her keyworker daughter with childcare. She added: "Thank you WHA

for all the support throughout this Covid crisis. God bless you."

Historic plaque returns home

A PLAQUE commemorating Warrington's links with prison reformer John Howard has been returned to its home after an absence of several months.

absence of several months. It was unveiled by deputy mayor Cllr Maureen Creaghan 113 years after it was originally installed in Bridge Street in 1907, when it marked the 130th anniversary of Howard publishing his works on prison reform in the 18th century. John Howard's famous book was

John Howard's famous book was printed in Warrington and while the work was being carried out he lodged at a silversmith's shop which stood on the site of the new

Warrington Market building. John Howard travelled England and Wales in the 1770s, visiting and Wales in the 1//Us, visiting hundreds of prisons, before writing his great work "The State of the Prisons" which was printed in Warrington

Warrington The plaque was originally erected by The Warrington Society. It displays the words: "Lodged at a silver smith's shop, which stood upon the site of these premises, whilst printing his great works on Prison Reform. 1777-80-84-89". The plaque was temporarily removed to avoid any damage being caused during construction work on the new market.

Council to delay Local Plan

DUE to the impact of COVID-19, along with the Government's proposed planning reforms and new housing calculation methodology, Warrington Borough Council is pausing work on its Local Plan.

The delay aims to give the council time to reflect and be confident that the Local Plan submitted for examination is the right one for Warrington, given the events of this year and the effects they are likely to have for years to come.

It is anticipated that the council will now be in a position to progress with the Local Plan in the summer of 2021.

Warrington consulted extensively on its 'Proposed Submission Version Local Plan' in the summer of 2019, attracting approximately 3,500 written representations from members of the public, landowners, developers and stakeholder organisations, as well as statutory consultees

In late 2019, the council informed residents that taking account of all of the representations and bringing forward the right plan, with the right infrastructure, had been a complex and challenging process and would take time.

While the council has continued to make good progress with the plan, a number of developments this year are impacting on the work

•The global impact of the •The Government's White Paper

for a reformed planning system, which may bring a fundamental transformation in the way the planning system is administered.

*s*eparate Government consultation on a revised method of calculating housing numbers when developing a Local Plan. While it is not yet clear how the new methodology would impact on the Local Plan, it could potentially affect the number of homes required for the borough. Council Leader,

Cllr Russ Bowden, said: "Our Local Plan will shape Warrington's future – and that's why it's vital we get it right. We have been working hard for many months to analyse each and every one of the representations we have received. This has taken time, but it's a crucial, central part of our commitment to balancing the housing and employment needs of the borough with protecting the green belt, while following

government policy. "We have been steadfast that roads and infrastructure must be delivered ahead of houses being completed – in particular in the proposed Garden Suburb area in South Warrington. We've been working closely with landowners and developers to ensure that this infrastructure can indeed be


delivered, and this work continues. "However, the landscape has now changed. Our efforts to deliver a Local Plan that works for Warrington have been impacted by developments beyond our control. The unprecedented challenges The unprecedented challenges of the coronavirus pandemic – challenges which will be with us for some time to come – have undoubtedly had an impact on the way society interacts, the way the town moves, and in particular the way Warrington does business.

"This, combined with two rounds of Government consultation on planning reform and housing calculation methodology – mean that we are currently in a period of uncertainty. It would, therefore, be ingercorrigitate to move choose be inappropriate to move ahead with the submission of our current plan to the Planning Inspector at



this time.

"It's only right we pause. We don't want to rush ahead with a Local Plan that wouldn't be the best fit for Warrington's future.

CARPE DIEM A NEW football league which aims to help men tackle obesity has kicked off in Warrington at Orford's

kicked off in Warrington at Orford's Jubilee Neighbourhood Hub. Taking place every Tuesday night outdoor team sport is not currently affected by the rule of six, or any national or local Covid restrictions as long as the facilities adhere to COVID-secure guidance. In nearby Wigan, where 41 players take part in the league, the combined total weight loss has been as high as 700 pounds – or 50 stone a season and some players have been known to drop as much as 70 pounds during a 14-week league. week league. The FA-endorsed scheme was

created by Andrew Shanahan, who fed-up with traditional weight loss classes primarily aimed at women, decided to develop a programme that combines the beautiful game with achievable weight loss goals for men.

Before matches, the players are weighed, which is followed by a 30-minute game of six-a-side, with extra goal bonuses awarded to teams based on the amount of

to teams based on the amount of weight players have lost. Public Health England data covering the time between April 2019 and March 2020 found that 62% of adults in England are overweight or obese, with four of the top 20 areas where rates are the highest being within the North West region – with four of the top 20 areas where rates are the highest in areas where rates are the highest in the North West, they are Knowsley (73.7%), Halton (70.6%), Wigan

(70.5%) and Tameside (70.5%). Furthermore, a study by University of North Carolina (UNC), Saudi Health Council and World Bank published in August found that people with obesity are at a greater risk of hospitalisation (113%), admission to intensive care (74%) and death (48%) from COVID-19:



Recent Government support for businesses and employees through Coronavirus pandemic

of the first period of extension the qualifying period is from 1st November 2020 to the date of the claim.

For the first period commencing on 1 st November 2020 the grant will be a taxable sum equivalent to 20% of the average monthly trading profit. The grant will be capped at a total of \pounds 1,875. Details of how and when to claim the grant for this period will be announced by HMRC, who are responsible for administering the scheme, in due course.

Details of the grant for the second period commencing on 1st February 2021 have not yet been published.

Coronavirus Loan Schemes

Loans taken out under the Coronavirus Business Interruption Loan Scheme will be extended from the current 5 years to 10 years. As before, interest will be payable by the government for the first 12 months, after which the liability will pass to the person taking the loan.

A new loan scheme will be introduced in January 2021, details of which will be announced in due course.

Over the past few weeks the Chancellor has announced a number of measures to support businesses and employees through the Coronavirus pandemic.

Job Support Scheme

The Chancellor has confirmed that the Job Retention Scheme will cease at the end of October as anticipated. He has now announced a new scheme, the Coronavirus Job Support Scheme (JSS), commencing on 1st November and lasting for 6 months. It has been designed to, hopefully, provide support to employees in "viable" jobs.

The scheme will be available to all small and medium sized businesses (SME) across the UK but there will be additional conditions on large businesses. SMEs are businesses that meet at least 2 of the following 3 conditions:

- Turnover below £25m
- Fewer than 250 employeesGross assets of less than £12.5m

In other words, the majority of businesses and employees!

Grants made under the scheme will be based on the employee's usual pay. The amount of the grant will be capped at a maximum £697.92 per month.

To be eligible for the scheme an employee must work for a minimum of 33% of their usual hours, and must be in a "viable" job. The wages for these worked hours will be paid by the employer as usual. For any hours unworked the employee will receive 2/3rds of their pay, and half of this (ie 1/3rd) will be met by the government under the scheme. The result is that an eligible employee will receive at least 77% of their pay.

As an example, an employee normally works 5 days a week and earns £350 per week. If they work 2 days under the JSS then the employer will pay 2/5th (£140) for these days. They will then receive a further £140 for the remaining 3 days. Of this, the government will pay a grant of £70 to the employer. Therefore, the employee receives a total of £280, of which £210 is paid by the employeer and £70 is paid by the government.

A couple of things to note:

• There is no contribution towards the additional employment costs, ie Employers NIC and Pension contributions.

• The employer will continue to be able to benefit from the Job Retention Bonus in respect of employees paid under the JSS. This is a one-off grant of £1,000 for all previously furloughed employees who are still retained at the end of January 2021.

Value Added Tax

The temporary reduction in VAT from 20% to 5% for restaurants, hotels, and cinemas will be extended to 31st March 2021. The reduction covers all turnover from these sources with the exception of the sale of alcoholic beverages.



The first item of clothing launched is a compression sock, which has been specifically designed to give an extra boost to performance – and they are looking to launch an activewear range as well.

Philbin added: "Our first product, the Gripz sock, can be worn for playing any sport, or for walking or going to the gym.

"Boots are getting a lot lighter these days and your feet can move around your boot quite a bit so the compression sock will give that extra boost.

"They have got silicone grips on the bottom of the sock and it gives you that extra 1% in the change of your direction and extra power. The grips we have got go up the back of the sock so they help prevent blisters.

Philbin and Hodgkiss are determined to turn Gripz into a huge success

and they also want to give back to their local community in the process. Philbin continued: "We want to build a solid brand. We want to do it properly and we want to make this a brand that people want to wear.

We want to let the business grow organically and we've set a target that we want to be sponsoring the clubs that we both played for at amateur

level within six to 12 months. "Jack played for Culcheth Football Club and so did I. I played rugby for Culcheth Eagles and Latchford Giants so we want to be sponsoring those teams down the line and give back to the clubs that gave so much to us.

One of our main goals is to give back to the community so hopefully it all works out well."
