Editor's Comment

DURING these unprecedented times it is disappointing that two of the town's political heavyweights have still not met for talks more than one year on from the general election.

Despite the ongoing pandemic and the recent flooding, Warrington South's Tory MP Andy Carter and Warrington Borough Council's Labour Leader Cllr Russ Bowden, have still not engaged with each ther with both and blazing again. other, with both men blaming each other.

I'm not here to point the finger of blame and indeed both men have provided me with evidence suggesting attempts have been made to correspond. But the facts are, at time of press, they have still not had any official dialogue to discuss the many issues facing our

This kind of situation is what turns people off politics and certainly doesn't do our town any favours, when Mr Carter is a direct route to Government and possible funding, while Cllr Bowden is in charge at the borough council, which needs the borougn council, which helds as much funding support as possible - especially in light of the much talked about £1.6b of borrowing.

While Mr Carter is urging for

While Mr Carter is urging better communications to help tackle the COVID-19 crisis, Labour Leader Cllr Bowden says Mr Carter has not responded to his written requests to meet, accusing the Tory MP of "politicising Covid and attacking those at the frontline dealing with it"

Mr Carter says Warrington

Council's effective 'one-party state' is bad for local democracy and will hamper the town's ability to recover from coronavirus.

More than a year after winning Warrington South's Westminster seat back from Labour, Mr Carter says despite asking, he's yet to have a one to one meeting with the Leader of the Council, who instead prefers to write letters criticising central Government but won't sit down and discuss the many pressing issues affecting "our town".

Mr Carter says that to support people during this challenging time, the Conservative government has provided grant support for businesses through Local Authorities to protect people's jobs and incomes, as well as delivering financial assistance to the council to protect key services provided for young people and the elderly.

Despite a 'farcical' lac

dialogue between his office and elected Labour politicians, Mr Carter says he's built good relationships with 'very professional' Senior Council Officers, in a bid to help move some of the most pressing issues in the Borough forward and has even received messages of support from some Labour Councillors who don't agree with the way decisions are being taken and feel isolated from the ruling

Town Hall leadership. Meanwhile, Cllr Bowden, forwarded me two letters which he says have been sent to Mr Carter but received no response, says the MP for Warrington South has never asked him for a meeting and not given him the courtesy of a reply. He went on to say he didn't engage in "tittle-tattle and gossip"

and was getting on with the very serious job of leading this Council during the Covid-19 crisis, ensuring that vital services can be delivered, supporting local businesses and protecting jobs.

We've already had a situation

in this town where a Labour leader and a Labour MP never met for talks and it simply isn't good enough, especially during such unprecedented times, that people elected to serve the people, don't work together for the good of our

It is now more important than ever that all political differences are put to one side and everybody work's together for the good of

Warrington.
We all have different opinions and political beliefs within our own circle of family and friends - but it doesn't stop us working together or helping each other in times of need.


Hopefully, in the coming weeks, I can report on a positive outcome from Mr Carter and Cllr Bowden working together for the good of our town.





Town rallies following the worst flooding in living memory

As the worst flooding in living memory hit Warrington, firefighters were called out to perform numerous rescue operations, with more than 100 people evacuated from their homes across the borough from Great Sankey to Lymm and various places in between, including 21 people from an independent hospital at Dallam, which was one of the worst greats hit areas hit.

Council leader Cllr Russ Bowden said: "We have been dealing with extreme weather and recorded water levels 450mm higher than we have ever recorded before, so despite council officers distributing up to 6000 sandbags and setting up pumps in other locations, there

up pumps in other locations, there were sadly a number of breached properties and flooded highways.

"I am extremely grateful for the work of our council officers, agencies, blue light services and housing providers for their committed efforts during what has been another challenging week for our town."

Meanwhile, Warrington North MP Charlotte Nichols says she will "fight tooth and nail" to get some of the £5.2 billion proposed government investment in flood defence, spent in Warrington, while Warrington South Warrington, while Warrington South MP Andy Carter is keen to know what more can be done to prevent further flooding

Mr Carter, who was out on the ground working with the Council, Environment Agency, Cheshire Police and residents to help get resources where they were needed, said: "Down the line I'm keen to understand what more can be done to protect homes and families in Dallam from this type of flooding, prioritising the clearing of ditches and improving defences."

More than £30m has already

been invested in the Warrington area on flood defence works in recent times, most notably along the Mersey on Knutsford Road, with the promise of more to come.

Meanwhile, members of the arrington business community Warrington and various volunteers showed true community spirit helping those in need, with thousands of pounds donated to a crowdfunding page set up by organisers of the Warrington

"Whether it be running, walking,


"Whether it be running, walking, cycling, sponsored diet or whatever little challenge you feel capable of completing – it will help you – and possibly a local charity as well.

Consultation underway on "exciting plans" to expand Bridgewater High School

CONSULTATION is underway on "exciting plans" to expand Bridgewater High School so that it can meet the anticipated increase in the number of students in the south of the town.

Following careful scrutiny and planning, Warrington Borough Council has identified the need to increase the number of secondary places following the significant level of new housing developments in the

Principal Tim Long says the "exciting plans," which will involve significant capital investment, are "a fantastic opportunity for the school" as it also allows the school to:

•transform teaching and learning facilities across both sites

 redistribute numbers more evenly across the two school sites

•provide a solution to the growing

pressure on school places
Mr Long added: "However, we
also want to make sure that as part
of any expansion we keep all our
stakeholders fully informed, giving them the appropriate opportunities to consult and feedback their views. "For the sake of clarity, this

consultation document addresses the increase in the Published Admission Number from 300 to 360 starting with Year 7 in 2023. The consultation over the Building Application is a

separate process.

The School has been asked by the Local Authority to increase its Published Admission Number (PAN) from 300 to 360, commencing in 2023 and starting with Year 7.

Because this is considered to be a "significant expansion" the school must consult in line with guidance from the Department for Education.

In order to accommodate an increase in numbers, we must also build additional capacity. We must also consult over this through a separate Building Application process.

The reason for the available investment for Bridgewater High school is that it has been identified as central to several housing developments in the local area and therefore is named as the school that will benefit from the funding in the \$106 housing developer contribution

for education places.

The Local Authority will be liaising closely with Bridgewater High School as it develops the site and expands the school roll to ensure as smooth a

transition as possible.

The High School is a large, 11-16 co-educational, secondary school operating across two separate sites in Appleton, Warrington. The School converted to an academy in December 2014 and is part of The Challenge Academy Trust (TCAT) which comprises nine schools and a Sixth Form Calleage III have in the Control of t Sixth Form College all based in the

wider Warrington area.

Bridgewater High School would usually admit 300 pupils into the

Year 7 cohort each year. Due to exceptional demand and appeals, the school now has more than 300 pupils in all Year groups. Due to significant housing developments creating the need for additional places, as well as the current basic need for more pupil places as evidenced by applications over the past 3 years, the proposal is to expand permanently the school's Pupil Admission Number (PAN) of 300 to 360. This would start in September 2023 with initial growth in Year 7 only.

A planning application has been submitted to expand the school which will also involve "sprucing up" parts of the existing school and also creating a health and wellbeing garden that will create an inviting and welcoming entrance.

The chosen contractors will be

"experts" having worked on similar projects and the works will be carried out so as to cause as least disruption

out so as to cause as least disruption as possible during term times.

Works impacting on existing buildings would only take place during school holidays.







Hospital receives first new state-of-the-art OPTOS machine

WARRINGTON Hospital is the first in the country to buy a new state-of-the-art OPTOS machine which will revolutionise the way patients with serious eye conditions, including diabetic retinopathy, are managed.

The Ophthalmic team at Warrington and Halton NHS Foundation Trust is delighted to receive the new diagnostic machine, worth over £200,000. It will primarily be used to monitor patients with diabetic eye disease, but there are many other ophthalmic conditions it will be used to detect.

Diabetic retinopathy – a complication of diabetes where blood vessels in the eye are damaged - does not tend to cause any symptoms in the early stages, but without prompt treatment can cause permanent blindness. Screening can detect problems before it affects vision, and OPTOS allows this scan to be undertaken quickly and easily, and with minimal time spent in

hospital – something essential during COVID and one of the driving forces behind purchasing the machine.

The prevalence of diabetes-related eye disease is 40% in the diabetic eye disease is 40% in the diabetic population and it is estimated that the number of people with diabetes will rise to 4 million in UK by 2025 – this, together with increasing life expectancy, poses daunting prospects on the current diabetic eye service. It is vitally important these patients are monitored.

The Optos Silverstone Advanced is a wide field fundus camera that captures images of the central, midperipheral and far peripheral retina. The images captured are wider than an ophthalmologist could see with a detailed face to face examination.



Tax Returns and **Assistance during Covid**

When you read this the deadline for the submission of 2020 self assessment tax returns will have passed.

The current environment remains extremely difficult for businesses and, in fact, are in many ways getting worse. The economy remains in lockdown due to the Coronavirus, and this will in all probability remain the case for a number of months. In addition, many businesses continue to face number of months. In addition, many businesses continue to face uncertainties following the exit of the UK from the EU trading block, despite the platitudes of the government. And if this was not enough, many businesses were impacted by the recent floods experienced in Mid-Cheshire.

HM Revenue and Customs ("HMRC"), despite repeated requests and submissions from many professional bodies, including the Institute of Chartered Accountants, and business associations, have and business associations, nave consistently refused to extend the filing deadline. Therefore, if you have failed to submit your return by 31st January then you will be automatically charged a penalty of £100. However, there is some relief in that HMRC have confirmed that if an appeal is lodged against that if an appeal is lodged against any penalty on the grounds that the delay is due to Coronavirus affecting either the taxpayer or their agent then they will accept that as a reasonable excuse and cancel the penalty.

We are currently writing this column some eight days before the deadline and are working hard at ensuring all Returns are submitted in a final form before that deadline,

and we are confident that where we have received the necessary information from clients, we will achieve this. However, like most businesses, we have been affected by Coronavirus, with people working remotely wherever possible for the past eight months, meaning that it may be more difficult for clients to get their information to us. In these few instances, we have decided as a practice not to rely on any statements from HMRC that penalties will be forgiven. Instead, we have decided that a Return will be submitted, wherever possible, for all clients, even if it is a provisional Return using estimated figures, with the additional difficulties caused by Coronavirus being given on the Return as the reason.

So where are we currently up to?

One of the major developments in the past month or so is the Supreme Court rulings, following appeals from the Financial Conduct Authority and various insurance companies against rulings in lower courts, that in many or most cases insurance companies must pay-out on claims brought under the policies due to Coronavirus.

We are accountants and not solicitors, and so are not qualified to advise in specific cases. However, it would seem that the claims fall into four main types:

- Losses due to disease
- Losses due to prevention of access
- Losses due to a combination of the above
- Losses compared to expected

If your claim falls into one of the above then you should find yourself covered. Our advise would be to contact your insurer in the first place. If you do not receive a positive response and wish to pursue it further then you seek legal advice.

Financially, there are a number of developments which you should be aware of.

Following the delay to the Autumn Budget we are expecting a budget in March. Following the extensive support that has been handed out to clients and individuals since the first period of lockdown it is expected that we may see some initial clawback of the cost of this support. Obviously, we cannot say what will be appear in the budget, but there are three areas which are often quoted as being areas that the government may look at:

- 1.Capital Gains Tax. Many commentators feel that there will be an increase in the rates of Capital Gains Tax and/or a reduction in reliefs available. Therefore, it may be advisable to ensure that any gains are made in the current tax year if
- possible.
 2. Stamp Duty. Many commentators give this as a potential area that
- may be looked at.

 3. Pension Relief. This has been an area that people have expected some reduction in the tax allowances for a number of

1.The fourth period of the Self Employed Income Support

Grant ("SEISS") covers the period from 1st February to 30th April. Applications for the third grant covering the three months to 31st January are now closed. The details of the fourth SEISS grant, and the exact qualifying conditions, had not been confirmed at the date of writing, but the third grant covered 80% of average trading profits up to a maximum of £7500.

- 2. The Coronavirus Job Retention Scheme ("JRS") continues at present up to the end of April. This covers 80% of the wages of "furloughed" employees up to a maximum of £2,500. The grant does not cover employer contributions for National Insurance or Pensions, 3.The Coronavirus Business
- Interruption Loan Scheme ("CBILS") and the Business Bounce Back Loan ("BBLS") both continue to be open to new applications. There have been no changes to the qualifying conditions. The BBLS is for smaller businesses and is available for loans up to £50.000. The CBILS scheme is for larger loans in excess of £50,000. Both are administered by a number of banks and other lenders, including Funding Circle, and applications should be and applications should be made directly to the relevant lender. Most have simple on-line application forms.
