Editor's Opinion

There is an old saying that if you don't have your say, you can't complain later. But when it comes to Warrington's Local Plan, the real question is whether enough people even realised what was at stake.

Based on the consultation figures, only around 1.5 per cent of Warrington's adult population took part in the process that will shape where thousands of new homes, employment sites and major infrastructure projects will be built over the coming decades. That statistic should concern everyone.

This isn't a criticism of those who took the time to respond. Far from it. Many residents, community groups and parish councils invested hundreds of hours studying complex planning documents running into thousands of pages. They deserve credit for engaging in what is an incredibly complicated process.

But 1.5 per cent is hardly a ringing endorsement of widespread public participation.

Whether that low figure reflects consultation fatigue, lack of awareness or simply the complexity of the planning system is open to debate. The reality is that many people only become interested when a planning application appears at the end of their road.

Following the Government's decision to increase mandatory housing targets for local authorities, Warrington Borough Council is consulting again on what those revised figures could mean for the borough's future. The new targets

have the potential to place even greater pressure on land availability, infrastructure and public services, raising fresh questions about how and where future development should take place.

Whether people supported the adopted Local Plan or opposed it, this latest consultation is an opportunity that should not be ignored. If residents believe the borough is growing too quickly, or alternatively that more homes are needed, now is the time to say so—not after decisions have been made.

The Local Plan has already generated fierce debate over Green Belt development, transport infrastructure, healthcare provision

and whether Warrington's growth ambitions are sustainable. Consultation should never become a box-ticking exercise. It should be about ensuring residents understand the choices facing the borough and have a genuine opportunity to influence them. At **Warrington Worldwide**, we've always believed in giving people the information they need to make informed decisions. But democracy only works when people take part. The previous consultation saw only around 1.5 per cent of Warrington's adult population respond. This latest consultation offers a chance to improve on that figure. The future of the borough is too important to be decided with so few voices taking part.

Giant 38ft Luke Littler mural created to celebrate World Champion's remarkable rise

A giant 38ft mural of reigning world champion Luke Littler was unveiled at Golden Square Shopping Centre in his hometown of Warrington, to celebrate one of darts' most extraordinary success stories.

Recognising the lasting impact Littler continues to have in inspiring the next generation of players, the striking artwork pays tribute to the teenager's remarkable rise from local talent to global sporting superstar and recognises the achievements that have cemented his place at the top of the game.

To mark Luke's historic back-to-back World Championship and World Matchplay triumphs, Target Darts also announced the launch of "Born To Win", a new signature range of Luke Littler darts products. Emblazoned across the mural, "Born To Win" reflects the mindset and determination that have defined Littler's meteoric rise, while celebrating a journey that has inspired millions of fans around the world.

Elsewhere, Target Darts, who manage and represent Luke, also announced that together with Luke, they will donate darts equipment to 63 schools across the local Warrington area, designed to introduce more young people to the sport at grassroots level, helping to inspire and develop the next generation of players. Target Darts also announced at a press conference in London, it's aim to inspire one hundred million people to play darts by the end of the

decade, triple the number of people playing today.

The day's celebrations began as crowds gathered at Golden Square Shopping Centre for the official unveiling. Luke Littler was joined by his family and friends, the Mayor of Warrington, local schoolchildren, members of the public and representatives from Target Darts, as the hometown hero came face-to-face with the artwork for the first time.

The mural, commissioned by Target Darts, Luke's sponsors, manufacturers and management team, in partnership with MurWalls, has been created as a permanent new landmark for the town, and celebrates the remarkable journey of a Warrington teenager who has become one of the biggest names in world sport.

The unveiling follows Littler's latest major title victory at the World Matchplay in Blackpool recently, where he produced one of the sport's most dominant performances, posting the highest tournament average in World Matchplay Darts history to successfully defend his title. It comes during a period in which his achievements have helped drive unprecedented interest and growth in darts across the UK as he continues his quest to win all eight PDC ranking

titles in the same calendar year, something that has never previously been achieved.

Speaking at the unveiling, Luke Littler said: "Growing up in Warrington, I never imagined something like this would happen. It's a huge honour to have a mural in my hometown and I'm incredibly grateful to everyone at Target Darts for making it happen. Hopefully it inspires young people here to believe they can achieve something special too. If it encourages even a few kids to pick up a set of darts and enjoy the sport, then that's something I'm really proud of."

After posing for photos in front of the mural, Littler joined darts commentator Dan Dawson for a Q&A session, where he reflected on his career and recent success. He then took to the stage alongside three local competition winners from a drawing competition organised by Golden Square Shopping Centre, which saw children submit hand-drawn pictures of Luke. The three lucky winners, personally selected by Luke, were invited on stage to meet him and throw some darts together in front of the Warrington crowd using Target Arcade, Target Darts' new connected entertainment platform, which was showcased to the public for the first time ahead of its official launch in October.

The Mayor of Warrington, who was also in attendance, paid tribute

to Littler's achievements, highlighting the positive impact he has had on young people across the region, through his success, dedication and connection to his hometown.

"Warrington is absolutely proud of Luke Littler. This magnificent mural right here in our community stands as a lasting tribute to Luke's extraordinary achievements on the world stage. It is more than just art, it is a powerful message to every young person across Warrington: dream big, work hard, and believe that you, too, can reach incredible heights."

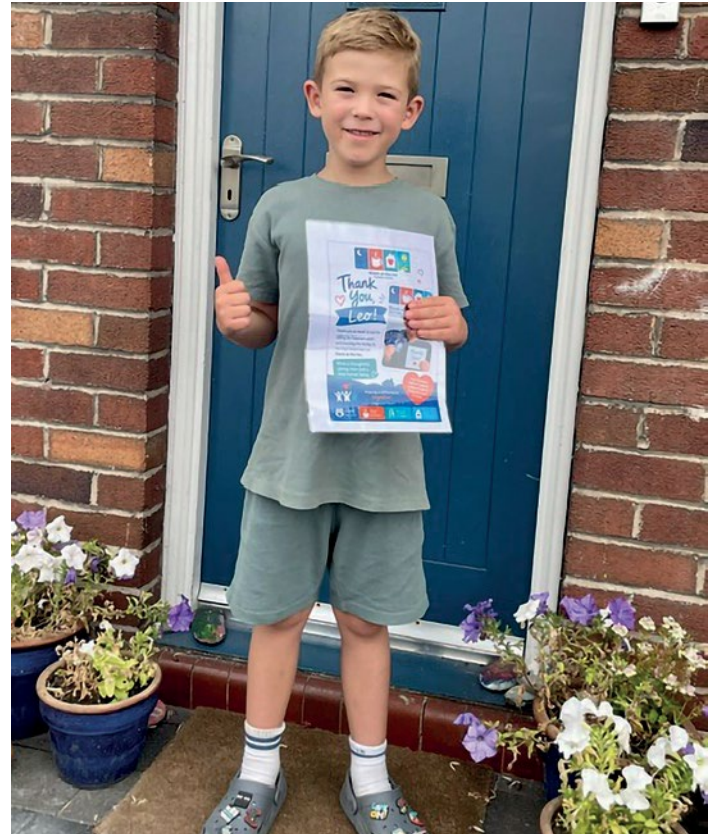
As Volunteer and Fundraising Co-ordinator Morven Turner says: "Sometimes the biggest acts of kindness come from the youngest members of our community."

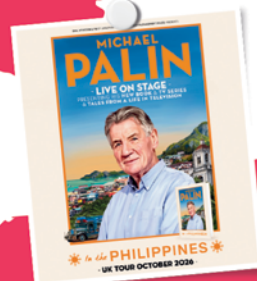

Priestley College celebrates another year of outstanding results

PRIESTLEY College Warrington is celebrating another year of outstanding results, with students achieving exceptional success across A-Levels, vocational qualifications and T-Levels.

As the largest provider of A-Levels in the local area, an incredible 100% pass rate was achieved in 30 A-Level subjects, with 61.5% of grades awarded at A*, A or B.

Among those celebrating was Evie Steele, who is heading to the University of Oxford to study Japanese and is already looking forward to spending time in Japan as part of her degree next year.

"The support of my teachers at Priestley has been amazing and I have just enjoyed every aspect of college life," said Evie, who achieved three A*s and an A. "Studying at Oxford is going to be amazing and I can't wait to get there."

Vocational and technical learners were similarly successful, with a 100% pass rate across 27 vocational subjects and three T-Levels.

Chloe Booth is heading to Manchester Metropolitan University to study Physiotherapy after securing D*D*D in Sport & Exercise Science.

Former St Nicholas High School pupil Lacey-Marie Kirk secured D*D in Protective Services and a Merit in Human Biology. She is now heading to the University of Worcester to study Paramedic Science.

"I'm most excited about the course, but also university life, the independence that will bring and how that helps you to become an adult," she said.

Priestley students are also

heading to some of the UK's most prestigious universities, including Cambridge, Durham, King's College London and Edinburgh.

Their chosen degrees reflect the breadth of subjects and interests across the college, including Ecological Environmental Science, Acting, Physiotherapy, Geography and History.

Josh Taylor is taking a different route, with a gap year ahead that will see him travel to Nepal to teach. The former Bridgewater High School pupil secured two A*s and two As and hopes to build valuable experience before pursuing his ambition of working in wildlife conservation.

"I'm hoping to get some real-life experience from my gap year before going to study at the University of Edinburgh," he said.

Priestley School of Performance Arts continues to produce exceptionally talented performers, with students progressing to prestigious conservatoires including Guildford School of Acting, Bird College and the Royal Northern College of Music.

For many students, the next step will be into the world of work, with a number progressing to higher-level apprenticeships with employers including Sellafield, Pacific Nuclear Transport, the NHS and Cheshire Fire Service.

Principal Paul Willerton said: "Today is a wonderful opportunity to celebrate the achievements of every Priestley student. There is

no single definition of success, and what makes these results particularly special is the sheer variety of achievements and destinations we are celebrating.

"From students securing places at some of the UK's most prestigious universities and conservatoires, to those progressing into higher-level apprenticeships, employment and exciting opportunities around the world, our students have demonstrated ambition, determination and resilience.

"We are incredibly proud of everything they have achieved and, most importantly, of the futures they are now able to build for themselves."

Vet's 100km challenge honours friend



A Grappenhall vet has completed a gruelling 100km challenge in just two days, raising more than £7,000 for a charity supporting the mental health and wellbeing of the veterinary profession.

Alexa Montgomery, from Rutland House Vets branch in Grappenhall, Warrington, took on the Peak District Ultra Challenge in memory of her close friend and fellow vet, John Ellis, who tragically died by suicide.

She was joined by John's partner, Ashley Andrews, from Northumberland, and Hampshire-based vet Stephanie Ellis, who is no relation to John. Together, the trio tackled the demanding route to raise funds for Vetlife, the charity that provides vital emotional, financial and mental health support to everyone in the veterinary community. Vets in the UK face an alarmingly high risk of suicide, with rates estimated to be three to four times higher than the general public.

Alexa raised £2,000 through her JustGiving page, while the team raised a combined total of £5,288. VetPartners, which owns veterinary practices and animal healthcare businesses throughout the UK and Europe including Rutland House, doubled Alexa's fundraising efforts for a grand total of £7,000.

John, who was godfather to Alexa's daughter, Lois, died in 2022 at the age of 35. He is remembered by those who knew him as a kind, compassionate and dedicated vet who cared deeply for both his patients and their owners.

The challenge saw the trio walk 50km on each of two consecutive days, spending around 14 hours

on their feet each day as they navigated the tough Peak District terrain.

Alexa said: "It was one of the toughest things I've ever done, both physically and emotionally. There were times when we were in tears because we were so exhausted, but we kept reminding ourselves why we were doing it and that gave us the strength to carry on."

"Reaching the finish line was incredibly emotional. Every blister, every aching muscle and every difficult moment was worth it because we have raised such an amazing amount of money for a charity that means so much to us."

"Vetlife does incredible work supporting people across the veterinary profession who are struggling, and we experienced that support ourselves around the time of John's death. Knowing that help is there for vets, nurses and practice teams when they need it most is invaluable."

"We never want another family, friend or colleague to go through that. If raising money and talking openly about mental health helps even one person reach out for support, then every step of those 100 kilometres was worthwhile. I hope this challenge also helps raise awareness of the pressures people in our profession can face and encourages anyone who is struggling to know they are not alone."

Responses to Local Plan amount to around 1.5 per cent of adult population

RESPONSES to the last Local Plan consultations in Warrington amounted to around 1.5 per cent of the adult population in the borough.

This compares to around just 0.56% of local populations nationally following new analysis from the Royal Town Planning Institute (RTPI), with the Institute warning that low public participation could undermine trust in planning reform.

The finding suggests that most people are not taking part in formal conversations about the future of their local area, despite local plans shaping the location of homes, high streets, schools, parks, roads and railway stations.

The analysis was published alongside a new white paper, Communications in planning: How better engagement can build trust with communities from the RTPI and its member magazine The Planner. The report argues that planning authorities need to communicate clearly, engage early and reach beyond the people who already participate in planning consultations.

A previous RTPI survey with YouGov found that 33% of the British public did not know how to get involved in the planning process, while 39% felt their participation would not make a difference. The same polling found that only 7% of the public had engaged with the planning system.

However, earlier research supported by the RTPI and delivered by Demos, The MIMBY Majority, found that 63% of the UK population would accept development under certain conditions.

The white paper warns that the challenge is becoming more urgent. Changes to the National Planning Policy Framework could mean every English local authority will be required to have a local plan in place within 30 months.

Without better engagement, the RTPI said, decisions risk feeling more remote, more opaque and more vulnerable to mistrust, misinformation and public opposition later in the process.

Simon Creer, Director of Communications and Engagement at the RTPI, said: "Planning, no matter where it is done, relies on proper communications and consultation. The public expect their voices to be heard. But there is an emerging feeling that planning is something that is done to people, not with them."

"There is a real risk that changes to the National Planning Policy Framework, as well as the additional layer of spatial development strategies, will add to this. The communities being consulted will be larger, the decisions more opaque and further away. Many people may not even be aware of which combined authority they are in, let alone be motivated enough to engage with planning at that level."

"Taken all together, we can see a system that will require more engagement, more communication and clearer explanation of what the system does and does not do. If we are to bring the more positively inclined communities along with us

and make this system work, then there is a large job of work to be done."

Robin Hutchinson, Director of The Community Brain CIC, said: "I'm not sure we should be overly surprised by the low figures of engagement currently experienced through formal and traditional routes. The language used and approaches taken can be a turn off even when if it does come to people's attention. Conversations need to be brokered earlier and in different ways so they are not directly linked to the need for specific responses."

"Create events and moments that allow people to talk openly about their area, their thoughts, concerns and hopes. Make space for them to tell their stories. You will find more insight and information from someone in this atmosphere than ever through a 'consultation'. We are always delighted by how open and ambitious people can be about where they live."

In response to the findings, a Warrington Borough Council spokesperson said: "We recognise the importance of engaging residents and stakeholders in the planning process and have undertaken extensive consultation throughout the preparation of the adopted Local Plan."

"Across the various stages of consultation, thousands of people and organisations took part and shared their views. This included:

1. 78 responses to the Regulation 18 Part 1 (Scope and Contents) consultation
2. 4,500 responses to the Regulation 18 Part 2 (Preferred Development Option) consultation
3. 185 responses to the Regulation 19 Proposed

Submission Version Local Plan consultation in 2019

4. 2,597 responses to the Regulation 19 Updated Proposed Submission Version Local Plan consultation in 2021

"The 2021 consultation received responses from 2,597 individuals and organisations, resulting in 6,922 individual representations, as many respondents commented on more than one aspect of the plan."

"Public consultation is a key part of the planning process and all representations submitted during Local Plan consultations are carefully considered as plans are prepared and progress through to examination and adoption."

"In March 2026, the Government introduced its new plan making system which emphasises the importance of early and meaningful engagement in the plan making process. In April to June 2026, we carried out the first stage of consultation on our new local plan: Scoping Consultation and Call for Sites. A key element of this consultation was to seek feedback on how we engage with local residents and stakeholders, to understand what has worked well previously and what we can improve upon as we prepare the new plan. We are currently processing all feedback received to this stage of consultation."

Warrington Council's Independent Group leader, Cllr. Stuart Mann, who has already questioned the Local Plan process said: "It's encouraging to see attention being given to how few people take part in the Local Plan process, because these decisions shape our communities for decades. I'd urge every resident to get involved as early as possible. Once a plan reaches the later stages, many of the key strategic decisions have already been made, so early

participation really does matter."

"At the same time, we have to ask an uncomfortable question: have many Warrington residents simply lost faith in the Local Plan process? If people look at an adopted Local Plan and then see proposals for well over 1,000 additional homes on Green Belt land in North Warrington that wasn't allocated in that plan, it's understandable that some will ask, 'What's the point?'"

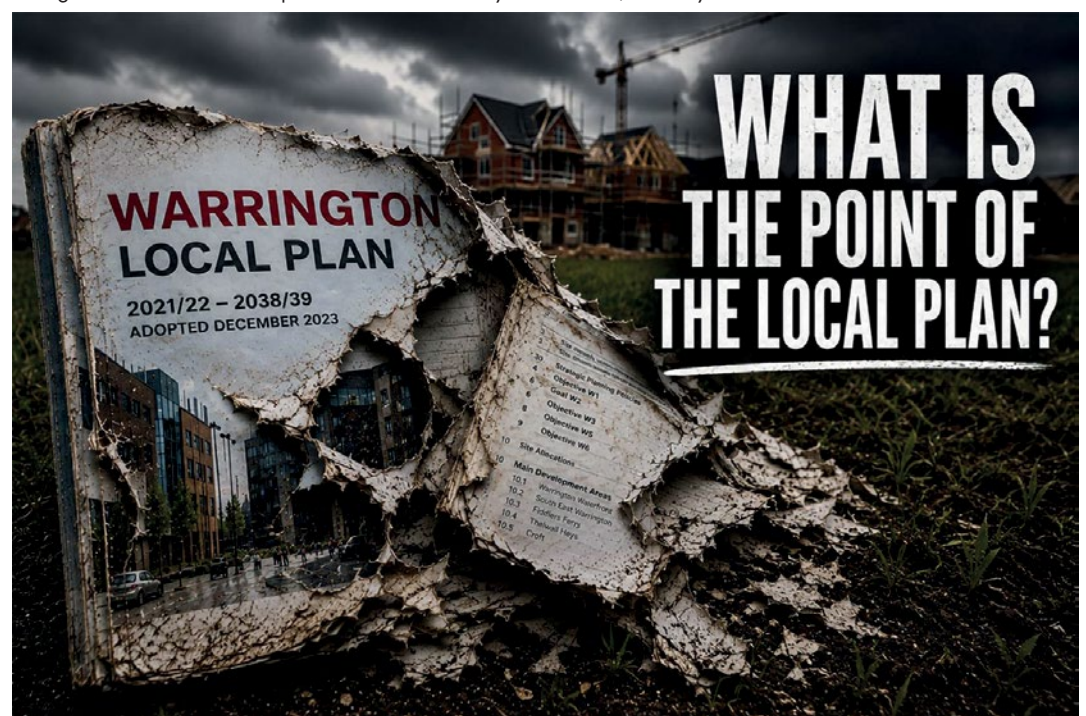
"For many communities, there was an expectation that by accepting the Green Belt releases identified in the adopted Local Plan, the remaining Green Belt would continue to be protected unless there were exceptional reasons to do otherwise. Rebuilding confidence means showing residents that local plans have real meaning, that infrastructure comes first, and that engaging with the process genuinely makes a difference."

Methodology: The key figure is that the 2021 consultation received responses from 2,597 individuals and organisations. The 6,922 representations were individual comments made by those respondents on different parts of the plan—they do not represent separate people.

Using the estimated adult population of 168,112:

- 2021 respondents: 2,597
- Adult population: 168,112
- Participation rate: $\frac{2,597}{168,112} \times 100 = 1.54\%$

So, around 1.5% of Warrington's adult population responded to the 2021 Local Plan consultation, and the true figure would be slightly lower because the 2,597 total includes organisations as well as individuals.



Private Scanning with Proper Clinical Assessment

In general practice, a scan is rarely the whole answer. It is one part of a careful process: listening to the patient, understanding the symptoms, considering risk and choosing the right investigation.

At our Antrobus clinic, we now have a private MRI scanner and ultrasound facilities. These are available to existing myGP Clinic members, but they are also open to people who do not use our GP service.

What we are offering is a

scan combined with a one-off "faster" appointment. This gives someone the opportunity to meet a clinician, discuss why they are considering imaging and ensure that the requested investigation is appropriate. There is no requirement to become a member

of the clinic.

MRI, or magnetic resonance imaging, uses a strong magnetic field and radio waves to produce detailed pictures of the body. It is useful for examining soft tissues, including the brain and spine, muscles, ligaments, joints and internal organs. It does not use X-rays.

Ultrasound uses high-frequency sound waves and is commonly used to investigate abdominal or pelvic symptoms, lumps and swellings, thyroid problems, muscles and tendons, and blood flow. It does not involve ionising radiation and is quick and well tolerated.

One area where earlier assessment can be particularly valuable is prostate health. Prostate cancer may develop without obvious symptoms, which is why men should understand their individual risk rather than waiting until something feels wrong.

At Antrobus, a prostate cancer assessment can combine a clinical appointment, a PSA blood test and a prostate MRI scan where appropriate. PSA measures a protein produced by the prostate. It is not a perfect cancer test: a raised result can have non-cancerous causes, while some significant cancers do not produce a markedly raised PSA.

MRI can provide detailed images of the prostate and may identify areas that require further specialist assessment. However, neither PSA



nor MRI can diagnose or exclude every prostate cancer on its own. The value lies in interpreting the results together, alongside age, symptoms, family history, examination where appropriate and clinical judgement.

This is particularly relevant for men with urinary symptoms, a family history of prostate cancer, Black men, who have a higher underlying risk, or anyone who wants an informed discussion about testing. Screening is not automatically right for every man, and the benefits and limitations should be understood beforehand.

Whatever part of the body is being investigated, the best scan is the one that answers a clear clinical question. Results must then be explained and followed up properly.

Spotlight on Local History with James Balme

The life and times of Latchford born Richard Comberbach 1644

The beauty of the Cheshire village of Lower Peover cannot be under estimated with its chocolate box cottages, it's wonderful old pub and stunning ancient church dating back to early medieval times.

The beautiful church of St Oswald with it's stunning tower dating to around 1500 AD stands side by side with the Warren de Tabley arms hotel, known to most visitors as the 'Bells of Peover', however the name of the pub has nothing to do with the church or its famous bells but derives its name from the 'Bell' family who owned the establishment in the 20th century.

Lower Peover stands approximately four miles south of Knutsford and is easily accessed from Warrington today. A popular destination for locals and visitors, Lower Peover is like taking a walk back through time.

But as well as the church and the nearby 'Bells of Peover' pub the village itself has a wonderful history of its own including an old schoolhouse with a great story to tell.

The schoolhouse was founded by one Richard Comberbach in the early 18th century and his life is a great story in itself. Richard was born in Latchford near Lymm in the year of 1644 and he was the son of a gentleman. In the year of 1665 Richard was to attend Cambridge university where he studied hard

to attain the highest qualifications possible. In 1687 Richard was to become the curate of St Oswald's church in Lower Peover. Richard was a staunch supporter of the Royalist Stewart monarchy and following the revolution of 1688 he resigned his position as curate with immediate effect. Richard was to remain in the area and he became a local farmer, however his lifetime ambition was to found his own school within the village.

It was in 1709 along with financial help from his wife Margaret that Richard purchased a plot of land in the South West corner of the churchyard where he went on to build his dream of a detached schoolhouse. In 1710 the doors opened for the first-time seeing Richard's lifetime ambition finally fulfilled. Richard and Margaret were to become the teachers of the school. They went on to appoint a Mr John Mear as the first master of the school who became well known for his manner and discipline. John remained at the school for many years to come and upon his death in the year of 1734 John was buried in the churchyard of St Oswald's close

to a large yew tree. The grave is still visible to this day and a marker has been placed next to the grave by the children who today attend the local village school nearby. The old schoolhouse is today used as a private children's nursery carrying on the tradition of education within its walls.

St Oswald's church is delightful place and the timber framed building and churchyard remains a great attraction to the many visitors as well as the local people who live close by. The church is still used regularly for worship and is at the heart of the community. The church is one of a very few such buildings to be supported purely by oak pillars and beams.

SIPPs explained: Taking greater control of your retirement savings

Pensions are often associated with workplace schemes where contributions are invested on your behalf with relatively limited involvement. A Self-Invested Personal Pension, or SIPP, takes a different approach, offering considerably more choice over how retirement savings are invested.

For people prepared to take a more active interest in their pension, a SIPP can provide valuable flexibility. However, that flexibility comes with rules around contributions, tax relief and eventually accessing the money.

What makes a SIPP different?

A SIPP is essentially a type of personal pension. Contributions are made into the pension, tax relief is available subject to the relevant rules, and the money is invested with the aim of building a fund for retirement.

The main difference is investment choice. Depending on the provider, a SIPP may provide access to shares, investment funds, investment trusts, exchange-traded funds, bonds and gilts.

Greater choice does not necessarily mean better returns, of course, and investments can fall as well as rise. Charges also vary between providers and investments, so platform fees, fund management charges and trading costs should all be considered.

Making contributions tax-efficiently

For most people, the standard pension Annual Allowance is currently £60,000. This measures the total pension input during the

tax year, including contributions made personally and by an employer. A lower allowance can apply to some higher earners and to people who have already flexibly accessed pension benefits.

There is also an important distinction between the Annual Allowance and the amount on which an individual can obtain tax relief. Personal contributions benefiting from tax relief are normally limited to 100% of relevant UK earnings, although someone with little or no earnings can usually contribute up to £3,600 gross each year.

Unused Annual Allowance from the previous three tax years can potentially be carried forward, provided the relevant conditions are satisfied. This can be particularly useful following an unusually profitable year, the sale of a business or when someone simply wants to catch up on pension funding.

Business owners should also consider employer contributions. A company can contribute directly to a director or employee's SIPP and, where the appropriate conditions are met, the company may obtain corporation tax relief. This can make pensions an important part of wider remuneration and tax planning.

Accessing your SIPP

A pension is, however, a long-term investment. Most people cannot currently access private pension benefits until age 55, with the normal minimum pension age increasing to 57 from 6 April 2028, subject to certain protected pension ages.

When benefits are taken, up to 25% can generally be received tax-free, although the amount is now normally restricted by the Lump Sum Allowance of £268,275 across an individual's pensions.

The remaining pension can potentially be left invested through pension drawdown, used to purchase an annuity, or withdrawn in lump sums.

Drawdown can be attractive because it provides flexibility over when and how much income is taken. It also allows funds to remain invested. However, this means investment risk continues into retirement and withdrawals need to be managed carefully to avoid exhausting the fund too quickly.

Taking taxable income flexibly can also trigger the Money Purchase Annual Allowance, reducing the amount that can subsequently be contributed to defined contribution pensions while retaining the usual tax advantages. The MPAA is currently £10,000 a year.

Combining pensions

Having a SIPP does not mean abandoning a workplace pension. It is perfectly possible to have both.

In particular, employees should think carefully before opting out of a workplace scheme where their employer contributes. Giving up employer contributions simply to move to a SIPP could leave them financially worse off.

Existing pensions can also often be consolidated into a SIPP, but transferring should never be automatic. Older schemes can contain valuable guarantees,

preferential annuity rates or other benefits that could be lost on transfer.

What happens on death?

SIPPs can also provide flexibility when passing pension wealth to beneficiaries. Pension holders should complete and regularly review their expression of wishes or beneficiary nomination, particularly following major life events such as marriage or divorce.

The tax treatment on death depends on a number of factors, including the member's age and how benefits are ultimately taken.

There is also a significant change approaching. From 6 April 2027, most unused pension funds and pension death benefits are due to be brought within the estate for Inheritance Tax purposes, making pensions and estate planning increasingly interconnected.

SIPPs can therefore be a powerful retirement-planning tool, particularly for people wanting greater investment choice and flexibility. The trade-off is that there are more decisions to make, and contribution, withdrawal and tax rules need to be considered carefully.

WORLD darts number one Luke Littler has landed another trophy, and there weren't any arrows or an oche in sight.

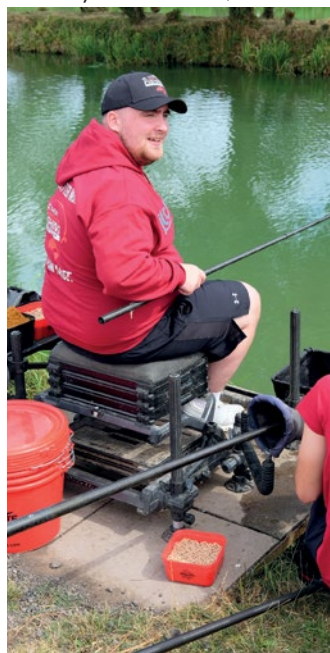
